Press Release

In response to the COVID-19 virus, the Monongalia County Sheriff's Office will be implementing the following safeguards as of March 19, 2020.

The access door to the Sheriff's Office lobby will be closed to non-essential personnel. Except in emergency situations.

Fingerprinting will be temporarily suspended for the general public.

NEW Concealed Carry applications will not be accepted until further notice because of personal contact with personnel.

RENEWAL of Concealed Carry permits will be done by mail only. This will require persons to send a money order for payment of any fees associated with the renewal. Any questions concerning this process, call the Sheriff's Office at 304-291-7260.

Copies of reports such as accident and incident reports can be obtained by calling the Sheriff's Office Monday - Friday between 8:00am - 3:00pm to request your report.

The report will need to be paid for by mail BEFORE the report(s) are sent.

Accident reports are also available through CRASHDOCS.ORG.

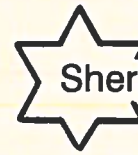
All calls for law enforcement will still be handled, however the following procedure will apply.

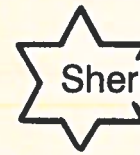
